



## **SERVPRO of Northwest Genesee County Addresses Basement Flooding Risks in Residential Properties**

Residential properties in Genesee County, Michigan, particularly those in established neighborhoods with aging housing stock, face heightened risks of basement flooding due to heavy rainfall, snowmelt, and sump pump system failures. These conditions often lead to water intrusion through foundation vulnerabilities, clogged drainage systems, and groundwater pressure, especially in communities such as Flint, Flushing, Clio, Montrose, and surrounding areas. As seasonal weather patterns bring periods of intense precipitation, homeowners in older homes encounter increased chances of water damage that requires prompt attention to mitigate further issues.

Heavy rainfall events have historically contributed to flooding across Genesee County, with reports of basement inundation during storms that overwhelm outdated infrastructure. Many homes in the region, built decades ago, feature plumbing and foundation systems that struggle under prolonged or intense rain. Sump pump failure remains a frequent factor, as these systems can malfunction during power outages, due to lack of maintenance, or when overwhelmed by rapid water accumulation. When sump pumps stop operating effectively, water enters basements quickly, affecting flooring, walls, insulation, and personal belongings. Foundation cracks and poor grading around homes exacerbate the problem by directing surface water toward

structures rather than away from them.

SERVPRO of Northwest Genesee County, Fenton, Lapeer, and Grand Blanc provides water damage restoration in Genesee County MI for residential and commercial properties affected by such incidents. The franchise specializes in the cleanup and restoration following water damage, including extraction of standing water, structural drying, and dehumidification to prevent secondary damage. Services extend to mold remediation to address any resulting mildew growth, as well as storm damage response that includes measures such as roof tarping and board-up when necessary. With 24/7 emergency services, the team responds rapidly to minimize disruption and begin mitigation processes. Joshua A. Ingersoll, Owner of SERVPRO of Northwest Genesee County, Fenton, Lapeer, and Grand Blanc, emphasized the critical nature of timely intervention. "Basement flooding from sump pump failures or heavy rainfall can escalate quickly if not addressed promptly, leading to more extensive structural concerns and potential mold development," Ingersoll stated. "Our structured approach focuses on thorough water removal and drying to help restore properties to their preloss condition."

Dean M. Dingman, Owner of SERVPRO of Northwest Genesee County, Fenton, Lapeer, and Grand Blanc, highlighted operational insights drawn from local experience. "In areas with aging infrastructure like parts of Genesee County, early detection of water intrusion signs, such as dampness or pump malfunctions, allows for more effective mitigation," Dingman noted. "Rapid response helps limit the spread of moisture and reduces the likelihood of long-term issues in residential basements."

Delayed response to water intrusion often results in mold growth within 24 to 48 hours under favorable conditions, which can affect indoor air quality and require additional remediation steps. Structural materials such as drywall, wood framing, and flooring may deteriorate when exposed to prolonged moisture, leading to weakened integrity and higher restoration complexity. Professional mitigation processes aim to arrest these progressions through controlled drying and targeted cleaning.
