



## **DUI Law Firm Denver Addresses Surge in Winter Resort DUI Arrests**

consequences from a single incident, including license suspension, substantial fines, and potential jail time."

The legal team emphasizes that Colorado maintains a blood alcohol content limit of 0.08 percent, with a DWAI (Driving While Ability Impaired) charge possible at 0.05 percent. Resort areas see increased enforcement during peak seasons, with checkpoints commonly established on highways leading from popular ski destinations.

DUI Law Firm Denver Attorney specialists note that penalties for DUI convictions in Colorado can include jail sentences ranging from five days to one year for first offenses, fines up to \$1,000, and license revocation periods extending from nine months to two years. Subsequent offenses carry increasingly severe consequences, including mandatory jail time and extended license suspensions.

"The consequences of a DUI conviction extend far beyond immediate penalties," added De Simone. "Professional licenses, employment opportunities, and insurance rates can all be affected. That's why mounting a comprehensive defense strategy from the outset is crucial."
