



## **The Weinstein Firm Decatur Reports Demand for Personal Injury Lawyers Among Record Traffic Deaths**

The Weinstein Firm reports sustained demand for personal injury representation as DeKalb County continues to record some of Georgia's highest traffic crash and pedestrian fatality rates, with 136 traffic deaths and 45 pedestrian fatalities in 2022 alone, according to the Georgia Governor's Office of Highway Safety.

The Weinstein Firm Decatur personal injury lawyer services have expanded to address the growing caseload as DeKalb County ranked second among all Georgia counties for both total traffic fatalities and pedestrian deaths in recent reporting. The county recorded more than 33,000 crashes resulting in over 9,500 injuries, placing it among the top three Georgia counties for collision-related injuries, according to state traffic safety data.

"DeKalb County residents face significant risk on local roads, and when crashes occur, insurance companies immediately deploy tactics designed to minimize payouts," said Michael Weinstein, attorney at The Weinstein Firm. "Georgia's modified comparative fault standard allows insurers to assign partial blame to victims,

reducing settlement values before legal representation becomes involved. Combined with the state's two-year statute of limitations, unrepresented victims often accept settlements below their actual damages."

The heightened accident risk in DeKalb County reflects broader statewide trends. Georgia ranked fifth nationally for traffic fatality rates in the first half of 2024, with 1.08 roadway deaths per 100 million miles traveled, according to the National Highway Traffic Safety Administration. Georgia pedestrian fatalities increased 12 percent between 2021 and 2022, according to the Georgia Governor's Office of Highway Safety, prompting DeKalb County to receive federal infrastructure funds to improve crosswalks and pedestrian signals.

The complexity of personal injury claims in high-accident areas like Decatur extends beyond initial insurance negotiations. Cases involving car accidents, truck collisions, pedestrian injuries, and premises liability require comprehensive evidence gathering, expert consultation, and strategic litigation planning. Georgia's two-year statute of limitations creates additional challenges as insurance adjusters employ delay tactics while unrepresented victims navigate the claims process.

The firm has received recognition from The National Trial Lawyers Top 100 and Top 40 Under 40. This professional standing affects settlement negotiations as opposing counsel considers the firm's trial preparation capabilities when evaluating settlement offers.

Decatur personal injury lawyer representation has become increasingly complex as insurance companies adapt their strategies to Georgia's comparative fault laws. The state's legal framework allows insurers to reduce payouts by assigning partial blame to accident victims, a practice that affects settlement values across DeKalb County's high-accident corridors.


