Additionally, homeowners should ensure gutters and downspouts direct water away from foundations, as excessive groundwater can overwhelm basement drainage systems.

The company notes that modern homes with finished basements face particular risks, as carpeting, drywall, and stored belongings can sustain extensive damage from even minor flooding events. Insurance coverage for basement water damage varies significantly depending on the cause, making prevention especially important for property owners.
