



## **Inflatable Party Magic Expands One-Stop Large Event Solution Across DFW with Addition of Stage Rentals and Restroom Trailers**

Cleburne-based company expands infrastructure offerings following growth in municipal and large-scale community event contracts across the DFW metroplex

Inflatable Party Magic, a party and event rental company serving the Dallas-Fort Worth metroplex since 2002, has added stage rentals and restroom trailer rentals to its event inventory, expanding its large event capabilities to cover entertainment, activities, and essential event infrastructure under a single vendor contract.

The additions follow a year of growth in municipal and large-scale community event contracts across North Texas, where demand for single-vendor solutions covering both entertainment and event infrastructure has increased among schools, churches, corporations, and local government organizations.

Stage rentals and restroom trailer rentals represent the two categories most commonly sourced through separate vendors by large event organizers in DFW. Their addition to Inflatable Party Magic's inventory means that organizations planning school carnivals, church festivals, corporate picnics, after prom events, community fairs, and municipal gatherings can now contract entertainment, extreme attractions, activity equipment, and core infrastructure through a single provider. The expansion reflects a documented shift in how large event organizers in North Texas are approaching vendor relationships. Event committees at schools, churches, and municipalities across DFW increasingly prioritize consolidated vendor contracts to reduce coordination complexity, streamline insurance and liability documentation, and maintain a single point of contact on the day of the event. Inflatable Party Magic has structured its inventory and staffing model to serve that need directly.

The company's large event inventory now spans four primary categories. Entertainment inflatables include bounce houses, water slides, obstacle courses, combo units, and toddler inflatables ? all certified under annual Texas Department of Insurance inspections required for inflatable amusement devices operating in the state. Extreme attractions include mechanical bull rentals, dueling mechanical bull rentals, rock climbing wall rentals, euro bungee trampoline rentals, bumper car rentals, Toxic Meltdown game rentals, and zorb ball rentals, each operated by a trained Inflatable Party Magic employee for the full duration of the event. Activity and ancillary rentals include trackless train rentals, carnival game rentals, portable mini golf rentals, dunk tank rentals, photo booth rentals, and concession machine rentals. Event infrastructure now includes tent rentals, table rentals, chair rentals, stage rentals, and restroom trailer rentals.

Texas Department of Insurance certification covers all inflatable equipment in the company's inventory, and the company carries general liability insurance with certificates available upon request ? documentation that school districts, municipal parks departments, and corporate event venues across DFW routinely require before approving vendor contracts. The company's cleaning protocol runs every rental item through five documented steps before delivery: debris removal, commercial-grade cleaning, sanitization with an EPA-registered hospital disinfectant, complete drying, and a pre-delivery inspection. If equipment does not meet the company's documented standard upon arrival at an event site, a staff member is dispatched to address the issue before the event opens.

The company's growth in municipal and community event work across DFW in 2025 was driven in part by the increasing scale of city-sponsored festivals, parks department events, and community gatherings that require both entertainment programming and physical infrastructure. Municipalities contracting for events with 200 to 400 or more attendees require vendors who can provide proof of insurance, state inspection documentation, and staffed supervision for attractions ? standards that Inflatable Party Magic has maintained continuously since its founding.

"Adding stages and restroom trailers was a direct response to what we were hearing from large event clients," said Chanda McFarland, President of Inflatable Party Magic. "Organizations running events at the municipal or institutional level were already booking everything else through us and then going to a second vendor for the stage or a third for restroom facilities. Bringing those categories in-house completes the solution they were already building with us."

Inflatable Party Magic serves 57 cities across the Dallas-Fort Worth metroplex including Fort Worth, Arlington, Mansfield, Burleson, Grand Prairie, Cleburne, Midlothian, Waxahachie, Weatherford, Granbury, Crowley, Cedar Hill, Colleyville, Grapevine, Flower Mound, Keller, Southlake, and North Richland Hills. Full details on large event rental services and the company's complete inventory are detailed in many customer-facing resources. A large event planning resource covering entertainment selection, infrastructure requirements, and vendor coordination for DFW events is available on the company's website.
