



1Charlotte Workers Compensation Lawyer Reports Interstate 85 Crash Data Analysis for Cabarrus County

The analysis examined crash data from the North Carolina Department of Transportation's most recent reporting period, focusing specifically on the segment of I-85 that runs through Cabarrus County. This section of interstate carries an estimated tens of thousands of vehicles daily, with traffic volume significantly increasing during weekday commute times.

Interstate accidents present distinct characteristics compared to other roadway crashes.
