"Wilmington's high-traffic corridors combined with North Carolina's contributory negligence rule create a perfect storm for injured drivers," stated Thomas York, Founding Attorney at NC Injury Law, PLLC. "Insurance companies move aggressively to establish even minimal fault on the victim's part, knowing that proving just one percent responsibility eliminates their obligation to pay anything. Victims who secure experienced legal counsel immediately after an accident are far better positioned to protect their right to recovery and navigate these tactics effectively."

National Highway Traffic Safety Administration data reveals that approximately 39,345 people died in United States motor vehicle crashes in 2024, representing a 3.8 percent decrease from 2023 but remaining eight percent above pre-pandemic 2019 levels. The number of injuries increased 2.5 percent to 2.44 million in 2023, underscoring the ongoing severity of traffic safety concerns nationwide.

The importance of swift action following a car accident cannot be overstated. Surveillance footage faces deletion, witnesses' memories fade, and electronic vehicle data has limited retention windows. Early legal intervention preserves critical evidence that often determines case outcomes.
