



## **Laiona Moving LLC Launches Property Manager Coordination Program to Improve Apartment Transitions Across Greater Boston**

The program establishes direct communication procedures between the company and property managers, leasing offices, and residential supervisors. The objective is to reduce scheduling conflicts, confirm building access requirements in advance, and improve overall move-day coordination in multi-unit buildings.

Apartment properties in Boston, Cambridge, Somerville, Roxbury, East Boston, Back Bay, and the North End frequently operate under elevator reservations, loading dock schedules, and parking regulations. Miscommunication during relocation can lead to delays, strained tenant relations, and unnecessary administrative burden. The new coordination program formalizes pre-move verification and documentation

steps intended to address those issues before crews arrive on-site.

Under the system, Laiona Moving LLC confirms building policies prior to arrival. This includes reviewing elevator booking windows, loading access procedures, certificates of insurance, time restrictions, and any required documentation submitted to property offices. Property managers receive scheduling confirmation and designated contact information before move day, allowing expectations to be clearly defined in advance.

"Our goal is to remove uncertainty from the process," said Ramy Laribi, owner of Laiona Moving LLC. "Property managers need clarity regarding arrival times and procedures, and residents need a transition that is organized and respectful of shared spaces."

When required, pre-arrival confirmations are conducted to verify stair access, hallway clearance, protective covering requirements, and entry permissions. Crews arrive equipped with floor runners, padded blankets, shrink wrap, and door protection materials to minimize impact on common areas and maintain building standards.

The program was developed following recurring feedback from both residents and building supervisors who identified communication gaps as a primary cause of move-day disruption. By standardizing coordination steps and establishing documented compliance checks, the company aims to create a predictable relocation framework for apartment communities throughout the region.

All services continue to be performed by in-house employees trained in structured handling procedures. The company does not subcontract labor. Moves are scheduled individually to maintain focus, reduce overlap between projects, and preserve accountability from arrival through final placement.

The Property Manager Coordination Program will be integrated into qualifying apartment and multi-unit relocations moving forward, forming part of the company's operational process.

Laiona Moving LLC operates seven days a week between 8 a.m. and 8 p.m. from its headquarters at 226 Main Street in Winthrop, Massachusetts. Founded in 2021, the company provides local and regional residential relocation services across Greater Boston using trained in-house crews and structured operational procedures designed to support organized apartment transitions.

Company representatives stated that standardized coordination also supports building policies that govern shared residential environments. Advance communication helps reduce congestion in hallways, stairwells, and loading areas during active move schedules. The process also assists residents who may be managing

work schedules, family obligations, or lease deadlines while preparing for relocation. By confirming expectations early and documenting access conditions, crews can arrive prepared with the right equipment and time allocation for each property layout. This structured preparation supports smoother transitions for residents while helping property managers maintain building order, safety, and consistent operational standards during relocation periods across Greater Boston communities.
