Participation in Peacefest at Tigers for Tomorrow in Attalla provided another platform for health education. The event, held in Etowah County, allowed the clinic to engage with attendees on wellness topics.

These activities complement the practice's health talks and postural screenings offered to workplaces, schools, and organizations throughout the area. Sessions address injury prevention and physical maintenance strategies.
