The firm's CEO and founder, Edward Gelb, was one of the CLE presenters. He delivered a session titled "From Overworked Technician to Attorney CEO: How to Build a Predictable, Profitable Law Practice Without Burning Out" and joined other speakers to address the realities of leading a modern solo or small firm.

The Solo/Small Firm Success Summit Seminar brought together attorneys who lead or manage solo and small practices for a program focused on the operational, business, and client-facing aspects of law firm management. Gelb's presentation examined how attorneys can move from an overextended, technician-focused role into a leadership role that helps them run their firms more sustainably.

Speaking to an audience of solo and small firm lawyers, he described how many practitioners find

themselves managing every aspect of their practices, from casework and client communication to operations and marketing. During the talk, Gelb focused on how predictable systems, stronger profitability, and intentional law firm design work together to support a healthier practice. He discussed how lawyers can clarify where their time and firm resources go, identify activities that most directly support growth, and gradually introduce systems that reduce chaos and reactive decision-making.

Drawing on Aurora Legal Marketing and Consulting's work with law firms, Gelb explained how a structured digital presence may help support a more consistent flow of inquiries over time. He described how clear messaging, accurate local information, and well-organized online content can help potential clients understand what a firm does and how to take the next step. These efforts can also help ease some of the pressure created by inconsistent referrals and reactive marketing efforts.

Gelb emphasized that becoming an Attorney CEO does not require attorneys to abandon their roles as practicing lawyers. Instead, he described a gradual transition in which practitioners develop habits and systems that support leadership, including more intentional delegation, thoughtful use of technology, and clearer standards for the types of matters the firm accepts.
