



The Weinstein Firm Addresses Sandy Springs Crash Statistics and New Legal Landscape for PI Cases

The Weinstein Firm, a personal injury law practice with its main office in Sandy Springs, Georgia, is highlighting concerning crash statistics that position the city as one of Georgia's most collision-prone areas despite its relatively small population. The firm's attorneys are addressing how recent legislative changes through Georgia Senate Bill 68 have fundamentally altered the legal landscape for personal injury claims in the region.

Sandy Springs recorded 4,506 total crashes in 2023, resulting in 1,456 injuries and 8 fatalities according to Georgia Department of Transportation data. Despite representing less than one percent of Georgia's population, the city accounted for approximately 1.2 percent of the state's total crashes, a rate roughly 20 percent higher than its population share would predict. The Weinstein Firm Sandy Springs Personal Injury Lawyer practice has observed that distracted driving remains a dominant factor, contributing to 52 percent of all crashes in Fulton County based on recent reporting.

"Sandy Springs' position at the convergence of GA-400, I-285, Roswell Road, and Abernathy Road creates sustained collision exposure that our local residents face daily," stated Michael Weinstein, Personal Injury Attorney at The Weinstein Firm. "Combined with SB 68's new evidentiary rules, particularly regarding seat belt usage and damage arguments, injury victims who delay legal representation risk having their claims shaped entirely by the insurer's narrative. Our location here in Sandy Springs means we understand these corridors and the unique challenges our neighbors face when pursuing fair compensation."

The implementation of Georgia SB 68 in April 2025 introduced several critical changes affecting personal injury claims. The legislation now restricts attorneys to arguing pain and suffering values directly tied to the evidentiary record, eliminating previous anchoring arguments. Additionally, either party may now demand bifurcated trials separating liability and damages determinations. Perhaps most significantly for Sandy Springs accident victims, non-use of a seat belt is now admissible evidence to establish comparative fault or reduce damages in motor vehicle cases.

These changes arrive as Fulton County, where Sandy Springs is located, recorded 51,572 crashes in 2024, including 944 suspected serious injuries and 93 fatalities, ranking first in Georgia for total crash volume according to the Georgia Governor's Office of Highway Safety. The I-285 corridor through Fulton County experiences more fatal crashes than any other road segment in the state.

Under Georgia's modified comparative negligence system, individuals found 50 percent or more at fault cannot recover any damages. With distracted driving defense teams routinely arguing victim inattention as a partial fault basis, and the new seat belt admissibility rules providing insurers additional leverage, the complexity of pursuing fair compensation has increased substantially for accident victims.

The Sandy Springs Personal Injury Lawyer team at The Weinstein Firm emphasizes that immediate legal intervention has become increasingly critical given these legislative changes and the city's elevated crash rates. 
