The joint study by the Georgia Governor's Office of Highway Safety and Emory University's Injury Prevention Research Center revealed that distracted driving contributes to 55 percent of all motor vehicle crashes statewide, with Atlanta drivers showing distraction rates 38 percent higher than the rest of Georgia.

"The GOHS and Emory findings confirm what we observe daily in our Atlanta personal injury practice - distracted driving has become the dominant factor in metro area crashes, creating unprecedented risks for all road users," stated Humberto Izquierdo, Jr., Founder and Personal Injury Attorney at the Law Offices of Humberto Izquierdo, Jr., PC. "Our combination of insurance defense experience and bilingual capability allows us to aggressively pursue distracted driving claims while ensuring Atlanta's diverse injury victim population has direct access to experienced legal representation without language barriers."

The 2024 report's data reveals particularly troubling statistics for the Atlanta area. Emory University researchers found that approximately 18 percent of Atlanta-area drivers operate while distracted, compared to 13 percent for the rest of Georgia. In 2023 alone, distracted driving contributed to 12,779 crashes in Atlanta, representing approximately 39.4 percent of the city's total 32,000 crashes that year according to the Georgia Department of Transportation Crash Data Portal.

These statistics gain additional significance in light of Georgia Senate Bill 68, signed in April 2025, which introduced new restrictions on how noneconomic damages may be argued before juries and modified seat belt admissibility rules affecting comparative fault assessments in Atlanta car accident cases. The firm's three-attorney team, including Armando D. Izquierdo and Grant Tall alongside founder Humberto Izquierdo, Jr., brings multi-attorney depth to complex personal injury cases across the full spectrum of practice areas.
