Eligible dependents included spouses and immediate family members, enabling consolidated residency planning under a single program framework.

"The extension of the Bronze membership provides continued flexibility for new applicants evaluating long-term residence options in Thailand, while the family promotion demonstrated strong demand among existing members seeking to formalize residency arrangements for their families," said Rex Baay, Senior Immigration Consultant at Siam Legal International. "For applicants navigating these options, proper sequencing of applications, membership upgrades, and document preparation remains critical to ensuring a smooth approval process."

Eligibility requirements for the Thailand Privilege program include holding a valid passport, maintaining a clean immigration record with no history of overstays, absence of serious criminal background, no record of bankruptcy or legal incapacity, and parental consent for applicants under 20 years of age. These criteria apply to both primary applicants and any dependents included under the membership.

As an authorized GSSA, Siam Legal International facilitates the application process while ensuring that all membership fees are paid directly to Thailand Privilege Card Co., Ltd. only after approval.
