



## **PuroClean of Poughkeepsie Water Damage Restoration Service Prepares for Spring Thaw Surge in Water Damage Claims**

The Poughkeepsie-based restoration company reports that March through May typically sees a 40 percent increase in water damage calls throughout Dutchess County as warming temperatures create conditions that can overwhelm residential and commercial drainage systems. The company has expanded its emergency response team and updated its equipment inventory to handle the anticipated surge in service requests.

"Spring thaw creates a perfect storm of conditions that can lead to significant water damage," said Jon Beever, co-owner of PuroClean of Poughkeepsie. "Ice dams on roofs begin melting, frozen pipes thaw and sometimes burst, and heavy spring rains combine with snowmelt to create flooding risks. Property owners need to be especially vigilant during this transitional season."

PuroClean of Poughkeepsie - Water Damage Restoration specialists utilize thermal imaging technology and moisture detection equipment to identify water intrusion that may not be immediately visible. The company's certified technicians employ industrial-grade air movers and dehumidifiers to extract water and thoroughly dry affected structures, preventing secondary damage such as mold growth.

The restoration company serves residential and commercial properties throughout Dutchess County, including Fishkill, Wappingers Falls, Hyde Park, and Hopewell Junction. Their 24-hour emergency response team coordinates directly with insurance companies to streamline the claims process for property owners dealing with water damage emergencies.

Common spring water damage scenarios include basement flooding from groundwater seepage, roof leaks from ice dam formation, and pipe failures as frozen plumbing systems thaw. The company emphasizes that rapid response is critical, as water damage can compromise structural integrity and create health hazards within 24 to 48 hours if not properly addressed.

"We see many property owners attempt to handle water damage themselves, but professional restoration requires specialized equipment and expertise," added Beever. "Our teams understand the science of psychrometry - the relationship between temperature, humidity, and airflow - which is essential for proper structural drying and preventing long-term damage."

PuroClean of Poughkeepsie NY maintains partnerships with local contractors and building inspectors to provide comprehensive restoration services that go beyond water extraction. Their reconstruction division can address structural repairs needed after significant water damage events, returning properties to pre-loss condition.

The company recommends property owners inspect their properties now for potential vulnerabilities, including checking gutters and downspouts for ice blockages, monitoring basements for signs of water seepage, and ensuring sump pumps are functioning properly.
