Richard Barcum, President and CEO, will lead two sessions addressing mandatory electrical maintenance requirements under NFPA 70B and excavation safety protocols under OSHA Subpart P standards. The first session, titled "From Optional to Essential: NFPA 70B Compliance," addresses recent changes that transform previously recommended electrical maintenance practices into mandatory requirements. The presentation breaks down the standard's new provisions,

explaining which equipment requires maintenance, appropriate intervals, and implementation strategies for organizations without existing electrical maintenance plans. The second session, "Excavation Safety: Here's the Dirt," confronts one of construction's most persistent hazards by examining soil classification requirements, protective system specifications, and the critical role of competent persons in daily site inspections. Michaela MacRitchie, Director of EHS Services, will present the third session, "Are You Willing to Protect What Matters Most," which examines the psychological and organizational barriers that prevent workers from addressing unsafe conditions in real-time. The session provides frameworks for overcoming these barriers and fostering environments where workers feel empowered to intervene when they observe unsafe conditions.

All three sessions carry SHRM accreditation, allowing human resources professionals to earn continuing education credits while gaining safety expertise applicable to their organizations. Electrical failures remain a leading cause of workplace fires, equipment downtime, and worker injuries, making the regulatory shift in NFPA 70B particularly significant for facilities managers and safety directors. Trenching and excavation work continues to result in preventable fatalities despite well-established OSHA standards, making Barcum's excavation safety presentation especially relevant for field supervisors, safety coordinators, and contractors responsible for excavation operations.

At Booth #911, Cardinal will highlight its specialized site safety staffing services, which have become a core offering for the firm. The service addresses a common challenge faced by construction and industrial operations: the need for qualified safety oversight during project-specific timeframes without the commitment of permanent hires.
