

Auxilion Invests ?1.5m to Expand Advisory Services Practice

Auxilion, an Irish digital services provider, has announced a ?1.5 million investment in the expansion of its Advisory Services practice as part of a broader three-year growth strategy aimed at addressing rising demand for governance, risk, and compliance expertise across Irish businesses.

The investment comes as regulatory complexity continues to grow across industries, accelerating demand for cloud-based and automated compliance solutions. Auxilion reports that the expanded practice is forecast to increase customer revenues by ?5 million in 2026, supported by a strengthened digital services portfolio that spans digital readiness, strategic project portfolio management, governance, risk and compliance, IT service operations, and operational resilience.

Eleanor Dempsey, who was recently appointed Director of Advisory Services and Director of Strategy, Innovation and Transformation, will lead the practice. To support the expansion, Auxilion will build out its associates model by hiring 12 additional consultants and associates by the end of 2027. The recruitment effort follows a period of significant headcount growth at the company, which has brought on more than 30 new employees over the past twelve months to strengthen its commercial operations, leadership team and digital capabilities.

The Advisory Services expansion represents a key milestone within Auxilion's broader three-year strategy, which includes a ?10 million investment allocated to evolving the company's digital services offering, business capabilities and technology portfolio. The company positions the advisory practice as a vehicle for enabling clients to accelerate digital initiatives, strengthen operational resilience, achieve compliance outcomes and unlock measurable business results.

Dempsey commented on the strategic rationale behind the investment. "Investing in our advisory practice reflects our commitment to helping clients achieve digital readiness while effectively managing risk and

compliance," she said. "By delivering proactive, targeted, and continuous risk management solutions, we enable businesses to confidently navigate their digital journeys, unlock new opportunities, and drive sustainable growth."

Patrick Jordan, Chief Executive Officer of Auxilion, addressed the market conditions driving demand for governance and compliance expertise. "As organisations accelerate their digital transformation, the need for strong governance, risk and compliance frameworks has never been greater," Jordan stated. "In an increasingly complex global landscape, marked by regulatory change, cybersecurity threats, and economic uncertainty, GRC is becoming the foundation that enables companies to operate with confidence and scale safely."

Jordan further noted that the investment positions Auxilion to respond directly to a structural shift in how organisations approach digital transformation. "Digital transformation is not just about adopting new technologies; it requires a foundation of strong governance, effective risk management and embedded compliance," he said. "For Auxilion, this investment positions us to meet growing market demand while supporting our customers with the capabilities to build digital readiness while unlocking new opportunities for innovation and growth."
