## **Big Ben Lawyers Announces Expanded Legal Services for Car Accident Cases in Fresno**

"The complexity of car accident cases has increased significantly with the rise of rideshare services and commercial traffic on Highway 99," said Benjamin Charchian, Managing Attorney at Big Ben Lawyers. "Our expanded services include immediate accident scene documentation, coordination with medical providers, and comprehensive investigation of all contributing factors. We have adapted our systems to align with upcoming court requirements to ensure efficient case processing."

The firm's case management system now incorporates digital evidence preservation, medical record coordination, and insurance claim processing. These enhancements address the increasing complexity of personal injury litigation and evolving court procedures in California.
