



## **Markhoff & Mittman, P.C. Expands Work Injury Claim Focus**

In March, Markhoff & Mittman, P.C. announced an expanded focus on work injury representation for individuals and families seeking legal information after job-related accidents and benefit disputes. The announcement centers on the firm's work injury and workers' compensation practice and its efforts to make case information more accessible to people in and around Newburgh, NY.

"Work injury cases in Newburgh often involve medical records, employment documentation, and time-sensitive filings, so the firm's role is to help clients understand the legal process and the issues that may affect a claim," said Brian Mittman, Esq., attorney at Markhoff & Mittman, P.C.

The announcement reflects continued attention to matters involving workplace injuries, wage replacement claims, medical treatment disputes, and related hearings under New York's workers' compensation system. In many cases, injured workers must address several parallel issues at once, including employer reporting, insurance communications, treatment documentation, and questions about returning to work. The firm stated

that its current focus is on providing a structured legal review of those issues at an early stage of a case.

Markhoff & Mittman, P.C. states that it was founded in 1933 and continues to maintain a practice centered on representing people affected by workplace injuries and disability-related matters. The firm's public materials describe workers' compensation as a core practice area and explain that its work includes claims involving job-related injuries across New York. That history remains relevant in work injury cases because claimants may need to evaluate more than one legal or administrative path after an accident, depending on the facts of the incident, the medical evidence, and the status of any benefits already being paid. The firm stated that the present announcement is meant to clarify how those case reviews are being handled for prospective work injury matters associated with the Newburgh area.

Those materials identify the firm's team pages, contact channels, and practice descriptions, which the firm said are being used to support this announcement and to give readers a direct source for firm background and case-related information. The Newburgh work injury law firm said the announcement is also intended to address the practical reality that work injury claims are often discussed only after benefits are delayed, reduced, or disputed. By addressing the subject in a formal announcement, the firm aims to present the issue as a matter of legal process rather than promotional messaging, with emphasis on documentation, filing requirements, and case evaluation. That framing aligns with the firm's published materials, which focus on the structure of workers' compensation claims and related legal proceedings in New York.

Markhoff & Mittman, P.C. said that further updates on its work injury practice, firm background, and publicly available legal resources will continue to be posted on its official website. The firm noted that work injury matters may differ significantly based on accident circumstances, medical findings, and procedural status, and that its current announcement is intended to provide a general overview of the practice area rather than a statement about any single case.
