In contrast, Phuket Old Town offers a more moderated and family-oriented atmosphere, blending cultural activities with controlled water celebrations and local community events.

Other beach areas such as Kamala, Kata, and Bang Tao provide a more relaxed alternative, where visitors can experience a balance between traditional Songkran elements and leisure-focused beach activities. Premium beach clubs across the island are also expected to host curated events with controlled entry, appealing to travelers seeking a more structured and upscale environment during the festival.

“Phuket remains one of Thailand’s most dynamic Songkran destinations, but the scale and intensity of activity require careful planning,” said Omar O Manee, Attorney at Law at Siam Legal Phuket. “Travelers should secure accommodation and transportation in advance, remain aware of local regulations, and ensure they maintain proper immigration status throughout their stay.”

Due to the surge in visitor numbers, accommodation availability becomes increasingly limited, and transportation services may face disruptions, particularly in high-traffic areas such as Patong and major access routes. Visitors are strongly advised to pre-book hotels, confirm airport transfers, and allow additional time for travel across the island to avoid delays.

Siam Legal Phuket further emphasizes the importance of maintaining compliance with Thai immigration regulations during the festival period. Overstaying a visa, even during national holidays or periods of limited administrative access, remains subject to fines, blacklisting, and other legal consequences under Thai law.

Travelers are also encouraged to take practical precautions during Songkran, including safeguarding valuables with waterproof protection, carrying minimal personal items, and keeping vigilant in crowded areas during prolonged outdoor activities under high temperatures.
