membrane that removes a range of dissolved solids and contaminants, resulting in purer output compared to standard tap water. Culligan of Red Wing combines these filtration options with free water testing to identify specific issues present in a home's supply, allowing for customized system recommendations based on actual conditions.

The importance of such filtration has grown with increased awareness of water quality variations across communities. In areas served by wells or municipal sources, periodic testing reveals fluctuations in parameters that filtration can address. The company's service includes ongoing maintenance and repair for filtration equipment, with annual checks to ensure components function as intended and to replace filters according to usage and water quality factors. This approach supports consistent performance over time.
