His training included traditional hands-on techniques with emphasis on the Gonstead method and extremity adjusting. Prior to founding the practice, he owned and managed clinics in Wisconsin and Illinois. He holds Webster certification and has applied it in care for women during pregnancy and their families.

Dr. Jarrod Wise serves as associate chiropractor. The two doctors together contribute more than 25 years of combined experience. The practice addresses conditions that include back pain, neck pain, headaches, muscular tightness, tension, and issues related to accidents or injuries. Care plans are developed based on individual evaluations and focus on non-medication, non-surgical methods.

The 3D spine simulator functions strictly as an educational tool. It does not provide medical diagnoses, treatment recommendations, or substitute for professional clinical evaluation. Users interact with the interface by selecting and viewing spinal segments to observe illustrated connections to body regions. The resource is presented for informational purposes to increase awareness of anatomical relationships.

A note on the simulator page advises users not to submit any Protected Health Information. This guidance supports appropriate use of the online tool while maintaining standard privacy considerations for web-based educational content.

Additional educational materials at the practice include a bi-weekly newsletter available by subscription to both patients and non-patients. The newsletter covers topics such as stress reduction, disc conditions, regular adjustments, auto accident impacts, combined therapies, guidance on care provider selection, stretching techniques, headache management, and indicators for considering adjustments. Once subscribed, individuals gain access to a member wellness section with animated exercise videos and further articles.

The 2015 Chiropractic Alpharetta Patients' Choice Award, verified by Opencare.com, recognized the practice based on patient feedback from that period.

"Providing resources like the 3D spine simulator allows individuals to review basic spinal and neural relationships as part of general health information," said Dr. JJ Anthonijs, owner and chiropractor at Complete Family Healthcare.

The tool encourages exploration at the user's own pace without requiring personal health data.
