

Recent incidents include a life-flight rear-end crash near Exit 15 on GA-400 and a DUI-related fatal collision on GA-400 South. The timing of this expanded support coincides with significant changes to Georgia's legal landscape under Senate Bill 68, signed in April 2025. The new legislation directly affects how car accident claims are handled,

particularly regarding medical expense recovery and the admissibility of seat belt evidence in establishing comparative fault.

"The documented pattern of high-speed crashes on GA-400 through Forsyth County creates scenarios where insurance companies will increasingly leverage SB 68's seat belt evidence provisions to reduce claim values," stated Humberto Izquierdo, Jr., founder of the Law Offices of Humberto Izquierdo, Jr., PC. "Crash victims need immediate legal representation to preserve their rights before insurers can shape the narrative around comparative fault, especially in rear-end and rollover incidents where seat belt use becomes a central issue."

The Governor's Office of Highway Safety recently awarded the Forsyth Police Department a \$23,000 traffic enforcement grant specifically targeting crash reduction in the county, confirming government recognition of the area's elevated collision risk. Statewide, Georgia recorded 367,523 total car crashes in 2024, with distracted driving, speeding, and impaired driving identified as primary contributing factors.

For residents seeking a Cumming car accident lawyer, the firm emphasizes the importance of timely action given Georgia's two-year statute of limitations for injury claims. Evidence from GA-400 crashes, including traffic camera footage, vehicle black box data, and witness accounts, can deteriorate rapidly without proper preservation.

The firm's location at 108 Colony Park Drive in Cumming positions it to serve the approximately 270,000 residents of Forsyth County, which despite its larger population experienced fatal collision rates comparable to neighboring Hall County in 2024.
