Colorado operates under a modified comparative negligence standard, meaning that an injured party may

recover damages even if they bear partial responsibility for the incident, provided their share of fault does not exceed 50 percent of the total. Damages recoverable in personal injury matters include hospital and rehabilitation bills, medical expenses, past and future lost income, diminished earning capacity, and compensation for past and future pain and suffering, permanent impairment, and disfigurement. The specific recoverable categories and applicable limits depend on the circumstances of each case. TNS Associates evaluates each matter individually to identify the applicable legal theories and build a case strategy aligned with the specific facts and the client's circumstances.

"Personal injury cases involve some of the most difficult moments in a person's life, and the legal process that follows can feel overwhelming when someone is simultaneously managing their recovery," said Thomas N. Individuals who delay consulting with an attorney following an accident risk losing the ability to pursue a legal claim regardless of the merits of their case. TNS Associates accepts inquiries from prospective personal injury clients and conducts initial consultations to assess the facts of the matter and advise on available legal options.
