



Atlanta Accident Lawyers Responds to 2024 GDOT Statistics Showing 33,305 Traffic Crashes in Atlanta

Atlanta Accident Lawyers is addressing alarming 2024 crash data from the Georgia Department of Transportation showing Atlanta recorded 33,305 traffic crashes within city limits, averaging 91 crashes per day and resulting in 59 fatalities and 13,466 injuries.

The statewide figures paint an equally concerning picture, with Georgia recording 367,523 total traffic crashes in 2024, resulting in more than 143,000 injuries and 1,596 fatalities according to GDOT and the Governor's Office of Highway Safety. Atlanta alone accounted for nearly 10 percent of all statewide crashes despite representing a fraction of Georgia's total roadway miles.

Fulton County, which encompasses Atlanta, recorded 51,572 crashes, 944 suspected serious injuries, and 93 fatalities in 2024. A Propel ATL road safety study revealed that car crashes killed more people in the Atlanta metro area than homicides in 2024, with 425 crash deaths compared to 410 murders. Georgia ranked fifth nationally for traffic fatality rates in the first half of 2024, with 1.08 deaths per 100 million miles traveled.

"The 2024 data confirms what Atlanta motorists experience daily - our roads present extraordinary risk," said Shannon Ludwig, spokesperson for Atlanta Accident Lawyers. "Insurance companies understand these statistics better than anyone, which is why adjusters move aggressively to settle claims before victims understand their rights. Evidence degrades, witnesses become harder to locate, and unrepresented victims routinely accept settlements that cover only a fraction of their actual damages."
