Summerlin, Nevada continues to emerge as the preferred destination for California residents seeking tax advantages and lifestyle improvements, according to analysis from Keller Williams agent, Zach WalkerLieb.

The 36-year-old master-planned community spans 22,500 acres and features 10 golf courses, over 200 miles of trails, and more than 250 parks. These amenities, combined with proximity to Red Rock Canyon National Conservation Area and downtown Las Vegas employment centers, create an environment that rivals many California communities at a fraction of the cost.

Zach WalkerLieb mentioned in his recent post that current market conditions present particular advantages for California buyers. Inventory levels have increased approximately 30 percent year-over-year across the Las Vegas valley, creating more negotiating power for purchasers.
