



## **Mogy Law NC Addresses Complex Rideshare Accident Insurance Coverage Challenges in Raleigh**

The firm notes that victims of rideshare crashes face unique challenges navigating multiple insurance policies that shift based on the driver's status at the time of the accident.

North Carolina law provides up to \$1 million in combined liability coverage through Uber and Lyft when a driver has a passenger in the vehicle or is en route to a pickup, a figure that applies regardless of whether the driver's personal auto insurance covers the incident. When a rideshare driver is logged into the app but has not yet accepted a ride, Uber and Lyft provide \$50,000 per person and \$100,000 per accident in bodily injury liability coverage.

The increased presence of rideshare vehicles on North Carolina roads corresponds with concerning safety trends. A University of Chicago Booth School of Business study found that rideshare services are linked to a

3 percent increase in fatal accidents nationally, a rate researchers found persists across weekdays, weeknights, and weekends. National Bureau of Economic Research data attributes approximately 987 additional roadway deaths annually to the increased presence of rideshare drivers on U.S. roads.

Adding to the complexity for accident victims, the North Carolina Department of Transportation does not separately track rideshare accident data. Rideshare crashes are folded into the state's general crash statistics, making it difficult for victims to understand the full scope of rideshare risk without legal guidance.

"The insurance coverage in rideshare accidents operates on a tiered system that changes depending on whether the driver was logged in with no passenger, en route to a pickup, or actively transporting a rider," said Eric Mogy, Attorney at Mogy Law NC Raleigh rideshare accident lawyer. "Victims who don't understand these distinctions often file claims against the wrong insurer or accept settlements that fail to account for all available coverage. We see cases where injured parties leave substantial compensation on the table simply because they weren't aware of which policy applied to their specific situation."

Rideshare accident claims in North Carolina involve layered insurance coverage that requires careful analysis to determine which policies apply. The firm emphasizes that victims who attempt to navigate these claims without legal representation routinely encounter obstacles in identifying the correct insurer or calculating the full extent of available coverage.

Mogy Law's attorneys understand the specific coverage tiers that apply under North Carolina law and move quickly to preserve digital evidence, including GPS data, app records, and driver logs, before it is overwritten.
