



# **NC Car Accident Lawyers Addresses Complex Insurance Challenges Facing Durham Rideshare Accident Victims**

NC Car Accident Lawyers highlights the dual legal challenges confronting rideshare accident victims in Durham, where approximately 9,000 car accidents occurred in 2024 and North Carolina's contributory negligence standard creates heightened risks for those injured in Uber and Lyft collisions.

The firm notes that Durham rideshare accident victims face compounding problems that standard car accident victims do not encounter. Insurance coverage varies dramatically based on driver app status at the time of impact, while North Carolina's contributory negligence rule bars recovery entirely if a victim is found even partially at fault.

Durham County averaged 32 traffic fatalities and 3,823 car crash injuries annually from 2018 through 2022, according to NCDOT data. These baseline figures persist even as rideshare density has increased across the city's corridors serving Duke University, North Carolina Central University, and Research Triangle Park.

The complexity stems from tiered insurance coverage that changes based on driver activity. Under North Carolina law, Uber and Lyft provide \$1 million in combined liability coverage when a driver is actively transporting a passenger or en route to a pickup. However, coverage drops to \$50,000 per person when the driver is logged in with no active ride request.

"Durham rideshare accident lawyer cases require immediate action to preserve app data and GPS records before they are overwritten," said a firm representative. "Insurance adjusters representing Uber and Lyft are trained to contest app status to minimize available coverage while simultaneously probing victims for statements that can be used to assign partial fault. Under North Carolina law, even one percent of fault assigned to the victim eliminates all recovery."

The challenge is compounded by data limitations. NCDOT does not separately track Uber and Lyft collisions, making it difficult for victims to understand the true scope of rideshare risk without legal guidance. Meanwhile, rideshare services now account for as much as 13 percent of all vehicle miles traveled in some urban corridors, according to transportation research.

A University of Chicago Booth School of Business study found that rideshare services are linked to a three percent increase in fatal accidents nationally, a rate that persists across all days and hours of the week. This statistic takes on particular significance in Durham, given its status as a major Triangle-area destination.

The evidence window for rideshare accidents closes within days of a collision, particularly for app data and GPS records that establish driver status and coverage levels. This compressed timeline makes immediate legal consultation critical for protecting victim rights.
