According to the U.S. Bureau of Labor Statistics, private industry employers in Pennsylvania reported more than 117,000 nonfatal workplace injuries and illnesses in 2024. The same data set recorded an increase in fatal workplace incidents compared to the prior year, contributing to broader discussions about workplace

safety, regulatory compliance, and the legal processes that may follow serious job related incidents.

Schuster Law states that its work injury matters include workers' compensation claims as well as cases involving construction accidents, premises incidents, and other events in which an additional party may be involved. Under Pennsylvania law, workers' compensation benefits may address medical expenses and wage loss, while separate legal claims may arise when responsibility extends beyond the employer to contractors, property owners, or equipment manufacturers.
