



## **South Carolina Car Accident Lawyers Addresses Greenville County's Sustained High Crash Rates**

South Carolina Car Accident Lawyers has expanded legal support services for car accident victims in Greenville County, responding to newly published state data showing the county recorded 16,457 total traffic collisions in the federal fiscal year October 2023 through September 2024. The South Carolina Department of Public Safety Office of Highway Safety and Justice Programs data, published in January 2025, reveals 85 fatalities, 225 serious injuries, and 4,690 additional injuries from these crashes.

The firm's expanded services address a sustained pattern of traffic danger in Greenville County. Over the five-year period from October 2019 through September 2024, the county recorded 79,174 total collisions resulting in 436 fatalities and 1,152 serious injuries, making it one of the most consistently dangerous counties in South Carolina for motorists. The 2022 data showed Greenville County leading the state with 95 vehicle fatalities, surpassing both Horry County with 70 and Charleston County with 62.

"The five consecutive years of SCDPS data confirm Greenville County as one of the most dangerous

counties in the state for motorists," said Shannon Ludwig, spokesperson for South Carolina Car Accident Lawyers. "Accident victims on corridors like Woodruff Road and I-85 face insurance carriers experienced at handling high-volume claim environments who will move quickly to limit payouts. Local legal knowledge of Greenville County courts and the specific insurance companies operating in the Upstate region gives injured victims a meaningful advantage in securing fair compensation."

As a SC Car Accident Lawyer Greenville SC resource, the firm handles all communication with insurance carriers, gathers crash scene evidence, and builds claims that account for the full scope of medical costs, lost income, and long-term consequences. The expanded services specifically address the needs of victims injured on Greenville County's most dangerous corridors, where rapid growth and expanding logistics and commuter traffic on I-85 create recurring liability disputes.

First quarter 2025 crash data from Greenville County identifies White Horse Road, Woodruff Road, and Pleasantburg Drive as recurring high-crash corridors within the county. Interstate 85 also ranks among the region's most dangerous stretches. The county has historically led the state in total crash volume, recording more than 17,000 collisions in prior high-traffic years according to SCDPS data.

The sustained crash patterns reflect broader statewide trends. South Carolina averaged more than 1,000 traffic fatalities annually from 2017 through 2021, with the state's fatality rate consistently exceeding the national average on a vehicle-miles-traveled basis, according to NHTSA and SCDPS data.
