



## **Siam Legal Phuket Highlights Legal Impact of Global Sustainable Tourism Conference (GSTC) 2026 in Phuket**

The conference, hosted in Phuket from April 21 to 24, brought together global policymakers, tourism authorities, and industry leaders to outline Thailand's transition from high-volume tourism toward a value-driven model focused on sustainability, longer stays, and higher-quality visitor engagement.

This shift reflects a broader national strategy aimed at promoting low-carbon tourism, supporting community-based initiatives, and distributing economic benefits more evenly across secondary cities and local regions. Rather than prioritizing short-term visitor numbers, authorities are placing increased emphasis on long-stay travelers, responsible spending, and long-term economic contribution.

Omar O Manee, Attorney-at-Law at Siam Legal Phuket, noted that these developments signal a structural change in how Thailand approaches foreign participation in its tourism economy. "Thailand is clearly moving

toward a more regulated and value-oriented tourism environment," Omar said. "For foreign investors and property owners in Phuket, this means greater alignment between legal structures, environmental compliance, and long-term residency planning."

One of the key themes emerging from GSTC 2026 is the integration of sustainability into all aspects of tourism development. This includes stricter environmental standards, improved destination management, and increased participation from local communities. For investors, particularly those involved in hospitality, real estate, or tourism-related businesses, this introduces both opportunities and new compliance considerations.

"Developments that align with sustainability goals are likely to see stronger long-term support from regulators and local authorities," Omar explained. "However, projects that fail to meet these evolving standards may face increased scrutiny, particularly in areas such as land use, environmental impact, and operational licensing."

The Thai government has also emphasized the importance of extending visitor duration and increasing per-visitor value. This aligns closely with Phuket's positioning as a premium destination for long-stay travelers, retirees, and digital nomads. As a result, legal structures supporting long-term stays, property ownership, and business operations are expected to play a more central role in the island's economic framework.

GSTC 2026 also highlighted the importance of achieving Net Zero tourism goals, with initiatives focused on reducing emissions, minimizing waste, and promoting environmentally responsible operations. Event organizers implemented measures such as carbon offset programs, reduced plastic usage, and reforestation initiatives, reflecting a broader push toward sustainable practices across the industry.

For foreign stakeholders, these developments reinforce the importance of proper legal planning when entering the Thai market. This includes ensuring compliance with environmental regulations, structuring property ownership correctly, and aligning business operations with national sustainability policies.

"Phuket is evolving beyond a traditional tourism destination," Omar added. "It is becoming part of a more structured ecosystem where legal compliance, sustainability, and long-term planning are interconnected. Foreign investors who understand this shift early will be better positioned to succeed."
