All more than 20 employees live within Genesee County.

The company participates in local chambers of commerce in Flint, Fenton, Swartz Creek, and Flushing. Team members receive initial and ongoing training at SERVPRO's corporate training facility. They maintain regular IICRC industry certifications, including Water Damage Restoration Technician, Applied Structural Drying Technician, Fire and Smoke Damage Restoration Technician, Applied Microbial Remediation Technician, Odor Control Technician, Carpet Cleaning Technician, Upholstery and Fabric Cleaning Technician, Health and Safety Technician, Carpet Repair and Reinstallation Technician, Color Repair Technician, Floor Care Technician, Leather Cleaning Technician, Rug Cleaning Technician, and Commercial Carpet Maintenance Technician. The firm holds IICRC Certified Firm status. Employees additionally complete OSHA 10-hour General and Construction Industry Training, Employee Certification Training Program, and Lead-Based Paint Activities and Renovation requirements.

These qualifications support the application of established industry practices to each project. Restoration processes focus on returning properties to pre-damage conditions through systematic assessment, mitigation, and repair steps.
