



1Charlotte Injury Lawyers Addresses Rising Motorcycle Fatalities Amid \$127 Million Annual Economic Impact

1Charlotte Injury Lawyers is highlighting the disproportionate toll of motorcycle accidents in Charlotte and Mecklenburg County, where crashes involving motorcycles generate \$127 million in annual economic losses while representing 18 percent of traffic fatalities despite motorcycles accounting for only a small fraction of registered vehicles.

The economic impact encompasses medical costs, lost productivity, and property damage, with Atrium Health Carolinas Medical Center, a Level I Trauma Center on Blythe Boulevard, reporting that motorcycle trauma cases consume disproportionate emergency resources compared to other crash categories. Recent fatal crashes underscore the ongoing crisis, including a vehicle-motorcycle collision in Charlotte's Metro Division on August 23, 2025, and another fatal motorcycle crash on I-85 in northeast Mecklenburg County on August 21, 2025, both investigated by CMPD's Major Crash Investigation Unit.

CMPD recorded 38,400 total crashes in 2025, a nine percent increase over 2024, with motorcycles

accounting for the outsized fatality percentage according to NCDOT and CMPD Traffic Safety Unit data. The I-77/I-485 interchange led Mecklenburg County for motorcycle crashes with 31 documented incidents, while Independence Boulevard recorded 42 total motorcycle accidents in 2024. These corridors feature high speeds, complex merge zones, and limited motorcycle visibility that create recurring fatal crash conditions, according to NCDOT crash analysis.

"The \$127 million annual economic impact of Mecklenburg County motorcycle crashes means individual serious injury claims carry extremely high values, which prompts insurance carriers to deploy experienced defense teams and apply aggressive contributory negligence arguments from the first contact," stated a firm representative for 1Charlotte Injury Lawyers. "On Independence Boulevard and the I-77/I-485 interchange, insurers routinely challenge approach speed or lane position to assign even one percent of fault to the rider. NCDOT traffic camera footage from these corridors is typically overwritten within 30 days, making immediate legal contact the most important step a Charlotte motorcycle victim can take."

North Carolina's contributory negligence rule bars recovery entirely if the injured rider is found even one percent at fault. In Charlotte's high-density urban riding environment, insurance adjusters routinely argue that lane position on Independence Boulevard or approach speed at the I-77/I-485 interchange contributed to the crash, using any such finding to eliminate the victim's claim entirely.

Distracted driving accounts for 42 percent of Charlotte motorcycle crashes, speeding 31 percent, and DUI 18 percent, according to NCDOT crash causation data. Each represents a distinct liability scenario in which insurance adjusters attempt to assign partial fault to the rider under North Carolina's contributory negligence standard.
