



## Siam Legal Announces Thailand Privilege Next Member Promotion for Families

Under regular fee structures, supplementary membership for a Platinum holder costs 1,000,000 THB, while Diamond and Reserve holders pay 1,500,000 THB and 2,000,000 THB respectively per additional member. The Bronze and Gold tiers are individual memberships and do not include Next Member eligibility, and this promotion does not apply to them.

"This promotion is particularly well-timed for internationally mobile families who have been planning a long-term move to Thailand," said Rex Baay, Operations Manager and Senior Immigration Consultant at Siam Legal International, who accepted the firm's GSSA Awards in 2024, 2025, and 2026. "Adding a family member at 750,000 THB flat, regardless of tier, removes a significant financial barrier for couples and families who want to establish a stable, hassle-free and compliant long-term base in Thailand together." The Siam Legal Thailand Privilege team assists applicants at no charge beyond the official Thailand Privilege Card membership fee.

Each Next Member approved under this promotion receives their own Privilege Entry Visa, member card, and full membership privileges for the same visa duration as the primary member's tier, covering 10 years on Platinum, 15 years on Diamond, and 20 years on Reserve.
