



## **Mogy Law Analyzes Legal Challenges in Charlotte Motorcycle DUI Crashes Following Fatal Paw Creek Road Incident**

Following the August 25, 2025 fatal motorcycle crash on Paw Creek Road that prompted response from Charlotte-Mecklenburg Police Department's DWI Task Force, Mogy Law Charlotte motorcycle accident lawyer examines the legal complexities facing riders injured by impaired drivers in North Carolina.

The crash at 5600 Paw Creek Road in Charlotte's Freedom Division claimed the life of 64-year-old motorcycle rider Thomas Pruitt at approximately 8:22 PM, when his motorcycle collided with a Chevrolet SUV. CMPD's Major Crash Investigation Unit continues investigating the incident, with toxicology results pending.

This fatal crash represents part of a documented pattern in Charlotte. Impaired driving caused 88 motorcycle accidents in Charlotte during 2024, representing 18 percent of all motorcycle crashes, according to CMPD accident analysis data. Alcohol involvement was documented in 73 percent of fatal motorcycle crashes

occurring between 11 PM and 3 AM.

The impact extends throughout Mecklenburg County, where 58 alcohol-related traffic fatalities occurred out of 1,783 total traffic deaths in 2022. This means approximately one in four traffic fatalities in the county involved alcohol, according to CMPD data, even as DWI convictions dropped by approximately 80 percent during the same period, according to WFAE reporting on enforcement trends.

For motorcycle riders, North Carolina's contributory negligence rule creates specific legal challenges in DUI crash cases. When the other driver was legally impaired, insurance adjusters examine whether the rider operated above the speed limit, consumed any alcohol, or failed to take evasive action. Any finding of even one percent fault against the rider eliminates all recovery under state law, regardless of the other driver's impairment.

"When CMPD's DWI Task Force documents a driver's impairment in a motorcycle crash, the at-fault driver's insurance carrier immediately probes the rider for any fault they can establish," said Eric Mogy, Attorney at Mogy Law. "In late-night DUI crashes in Charlotte's entertainment corridors like South End, NoDa, and Uptown, bar surveillance footage, witness statements, and cell phone records showing the at-fault driver's behavior before the crash represent critical evidence that must be preserved through formal legal demands within 24 to 48 hours."

Charlotte's late-night entertainment districts present the highest concentration of impaired drivers between 11 PM and 3 AM, precisely when evidence-preservation windows are shortest. Traffic cameras, bar surveillance footage, and witness memories degrade rapidly in the hours after midnight crashes.
