



Carl Axen Clothier Expands Private Home and Office Suit Fittings

Carl Axen Clothier, a men's bespoke and custom clothier based in Orlando, Florida, has expanded the availability of its private home and office fitting service across Central Florida since its 2024 launch, allowing professionals and executives in Orlando, Lake Nona, and surrounding areas to receive a full clothier consultation and fitting without traveling to a studio.

The mobile fitting service operates alongside the business's by-appointment-only studio in Orlando. During a home or office appointment, clients receive the same consultative experience available in-studio, including guided fabric selection from mills including Holland & Sherry, Dormeuil, and Loro Piana, and may commission any garment from the full Carl Axen Clothier range, including bespoke suits, made-to-measure suits, custom dress shirts, custom sport coats, and custom blazers. The service currently covers Orlando, Winter Park, Lake Nona, Kissimmee, and the wider Orange and Seminole County areas, with coverage extending across Central Florida more broadly.

Carl Axen Clothier's mobile fitting model is designed to remove the practical barriers that prevent many professionals from engaging with bespoke tailoring services. For attorneys managing demanding court

schedules, C-level executives with international commitments, and senior business professionals whose time is consistently in demand, the ability to receive a private fitting at a workplace or home address changes what custom tailoring requires of the client. Through the mobile route, clients have access to the complete range of garments produced by Carl Axen Clothier. This includes bespoke suits manufactured at the business's proprietary New York tailor house through blue pencil pattern-making, a process in which an individual pattern is drawn from scratch for each client, as well as made-to-measure suits produced through a fully canvased, fully handmade CMT process. Custom trousers, dress shirts, and sport coats are equally available during mobile consultations, making it possible for clients to develop a complete professional wardrobe through appointments conducted entirely at their own premises.

The mobile fitting experience maintains the same standards of measurement, consultation, and fabric guidance that govern the in-studio process. No aspect of the service is reduced in scope or quality as a result of the location. A Carl Axen clothier conducts the appointment; fabric samples are presented at the fitting; and the garment production process follows the same construction standards, fully canvased, fully handmade, regardless of where the consultation takes place.

Carl Axen Clothier holds membership of the Custom Tailors and Designers Association (CTDA) and is listed on The Knot and Wedding Wire. The business serves both professional wardrobe clients and wedding clients, with grooms and groomsmen among those who commission custom tuxedos and bespoke suits in advance of their wedding date, an occasion that regularly draws clients to the clothier's full range of handmade garments.

"For many of our clients, time is the one resource they cannot afford to misuse. The mobile fitting model means we come to them, to their office, their home, wherever works, and deliver the same consultation and the same quality they would receive in our studio. Nothing is compromised," said Carl Axen, Founder of Carl Axen Clothier.

A secondary group of clients using the mobile fitting service are those making their first investment in a custom wardrobe. For professionals who have relied on off-the-rack clothing and are stepping into bespoke or made-to-measure tailoring for the first time, a private fitting at a familiar location offers a more accessible introduction to the process than a studio visit. Carl Axen Clothier's consultative approach, guided, unhurried, and centered on the individual, ensures that first-time clients receive the same depth of guidance as those who have commissioned custom garments previously.

Carl Axen Clothier serves clients across Central Florida through its Orlando studio and its mobile fitting operation, which extends the business's reach across Orange County, Seminole County, and the broader Orlando metro area.
