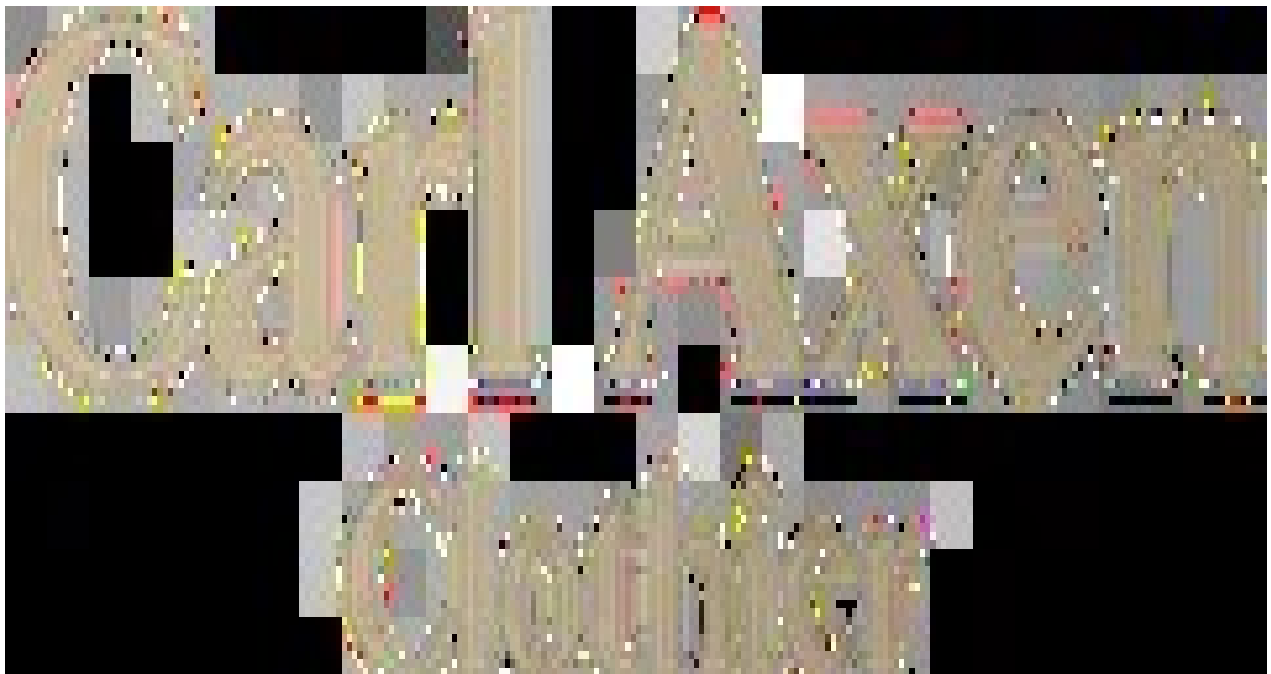




## **Carl Axen Clothier Broadens Bespoke and Custom Suit Fitting Reach**

Carl Axen Clothier, a men's bespoke and custom clothier operating from Orlabdo, Florida, has extended its mobile fitting service to the Tampa Bay market since establishing operations in 2024, serving professional and wedding clients across the region with fully handmade, investment-grade garments.

The business reaches Tampa Bay clients through its mobile fitting operation, in which a Carl Axen clothier travels directly to the client's home or office to conduct a full consultation and fitting. The service includes access to bespoke suits produced at a proprietary New York tailor house using blue pencil pattern-making, made-to-measure suits manufactured through a fully canvased, fully handmade CMT process, and custom tuxedos, alongside custom blazers, sport coats, trousers, and dress shirts. Carl Axen Clothier holds membership of the Custom Tailors and Designers Association (CTDA) and is listed on The Knot and Wedding Wire, reflecting the scope of occasions, from professional wardrobe development to black-tie event dressing, for which its services are commissioned. The business was featured in Sarasota Magazine in connection with its private fitting service across the Tampa and Sarasota area.

Tampa Bay supports a professional population that includes attorneys, C-level executives, wealth advisors,

and senior business professionals, the same client profile Carl Axen Clothier serves across Central Florida. For these clients, access to genuinely handmade, pattern-specific tailoring has historically required either travel or accepting garments marketed as custom but produced through offshore block-pattern processes. The mobile fitting model allows Carl Axen Clothier to serve Tampa Bay clients without a second physical location, bringing the full scope of the service directly to the client's preferred address. The business's custom tuxedo offering is of particular relevance to Tampa Bay's wedding market. Grooms and groomsmen who seek a fully handmade garment, one constructed to their individual measurements and intended to be worn beyond the wedding day, represent a distinct client profile from those purchasing or renting a standard wedding suit. Carl Axen Clothier produces its custom tuxedos to the same construction standards that govern all of its garments: fully canvased, fully handmade, and fitted from measurements taken during a private consultation. Fabric selection for Tampa Bay clients follows the same guided consultation process offered across all Carl Axen Clothier commissions. Cloth is sourced from mills including Holland & Sherry, Loro Piana, and VBC, giving Tampa clients access to the same quality of materials available to those visiting the Orlando, FL studio. Whether the commission is business attire, black-tie formalwear, or a garment for a specific career milestone, the selection process is consultative and structured to identify the most appropriate cloth for the intended purpose and long-term use.

All garments produced for Tampa Bay clients are built to the same specification as those produced for clients elsewhere in the business's service area. Full canvas construction, applied as standard to every suit and jacket in the Carl Axen Clothier range, allows each garment to conform to the wearer's body over time, a characteristic not shared by fused construction, which bonds an interlining to the fabric and does not adapt with wear. For clients commissioning through the bespoke route, each garment begins from a pattern drawn individually for that client at the New York tailor house, meaning no two clients share a pattern, regardless of similar measurements.

"Tampa Bay has a strong professional community and a significant wedding market, and there is genuine demand for garments built for the individual rather than adjusted from a template. We bring the full service directly to clients in the region, the consultation, the fabric selection, the fitting, and they receive the same product as anyone who walks into our Orlando, FL, studio," said Carl Axen, Founder of Carl Axen Clothier.

For Tampa Bay professionals at a career inflection point, taking on a board role, entering a senior leadership position, or preparing for a high-profile public event, the decision to invest in a custom or bespoke garment is increasingly connected to a recognition that off-the-rack clothing cannot deliver the fit, longevity, or presence

that their position requires. Carl Axen Clothier approaches each commission as an investment wardrobe decision, and the consultation process is structured to support that perspective from the first appointment through to the final fitting.

Carl Axen Clothier currently serves Tampa Bay through its mobile fitting operation and maintains its by-appointment-only studio in Orlando for clients across Central Florida.
