



Survivors of Abuse PA Announces Expanded Focus on Boarding School Sexual Abuse Litigation

Survivors of Abuse PA announced an expanded focus on legal representation for individuals pursuing civil claims involving alleged sexual abuse at boarding schools. The announcement comes as public attention continues to examine institutional accountability and survivor access to the civil justice system in cases involving educational environments.

“Boarding school abuse cases often involve events that occurred years or decades earlier, making it important for survivors to understand the legal options that may be available under current law,” said Ashley DiLiberto, Esq., attorney at Survivors of Abuse PA. “This area of litigation continues to raise important questions regarding institutional responsibility, record preservation, and access to civil remedies.”

The expanded focus reflects ongoing developments in sexual abuse litigation involving private educational institutions. Across the United States, survivors have filed civil claims alleging misconduct by school employees, administrators, and other individuals who held positions of authority within boarding school

settings. Many of these cases have also examined whether institutions maintained policies and oversight practices designed to address reports of misconduct and protect students.

As a result, litigation involving these institutions may involve questions concerning supervision, reporting procedures, disciplinary records, and institutional responses to allegations of abuse.
