



## **Survivors of Abuse PA Announces Focus on Boarding School Abuse Cases**

Survivors of Abuse PA announced its continued focus on representing individuals pursuing civil claims related to alleged abuse at boarding schools, as increased public attention and litigation activity continue to shape discussions about institutional accountability. Survivors may pursue claims against individual perpetrators as well as institutions alleged to have failed in their duties of supervision, reporting, or prevention. Courts evaluating such matters may consider institutional records, personnel files, internal communications, historical complaints, and other evidence relevant to the circumstances of each case.
