Claimants generally have 60 days from the date they receive the denial notice to request reconsideration, and the Social Security Administration presumes receipt 5 days after the date on the notice unless the claimant can show otherwise. Updated medical and vocational

evidence may also be submitted. At this stage, the claim is reviewed again by the agency, and both prior and updated medical and vocational information may be considered. For many Miami-area residents with serious medical conditions, assistance with reconsideration appeals can be important in keeping their claims active.

The firm works closely with claimants to gather medical records, document functional limitations, and address any gaps or inconsistencies that may have led to an initial denial.
