



All Around Fence & Decks Completes Cedar Privacy Fence Around Mature Tree

All Around Fence & Decks, a family-owned fence contractor based in Pasadena, recently completed a six-foot cedar privacy fence installation for a Glen Burnie homeowner that required precise positioning around a mature tree along the property line. The project highlights the company's approach to navigating site-specific obstacles that often complicate residential fence installations across Anne Arundel County.

The installation called for vertical cedar boards finished with a top cap, a style the company has built much of its 25-year reputation on. Cedar was chosen for its natural resistance to moisture and insects, qualities that matter on properties with established trees where soil stays damp and shaded for much of the year. The fence line was measured to preserve the root zone of the existing tree, a step that required adjusting post spacing and reviewing the layout on-site before any digging began.

Owner Jeremy Verhoef personally measured the property and was present during installation, consistent with the company's standard practice on every residential project. Posts were set below the frost line in concrete

footings sized for the soil conditions found across the I-97 corridor, where freeze-thaw cycles and Chesapeake Bay humidity put long-term pressure on fence structures. Utility locates were requested before digging, and the layout was reviewed against the property survey to keep the fence within setback requirements.

All Around Fence & Decks is licensed by the Maryland Home Improvement Commission under MHIC #97820 and carries an A+ rating from the Better Business Bureau with zero recorded complaints. The company has served Glen Burnie, Pasadena, Severn, Annapolis, and surrounding Anne Arundel County communities for more than 25 years, with both owners directly involved in measurement, installation, and final walkthrough on every job. Permit coordination, HOA paperwork, and inspector scheduling are handled in-house as part of the company's standard scope of work.

"After 25 years of building fences in this area, you learn that the obstacles on a property are usually what make the job worth doing right," said Jeremy Verhoef, Owner of All Around Fence & Decks. "A mature tree on a property line is not a problem to work around. It is a feature the homeowner wants to keep, and the fence has to respect that. The wrong contractor will cut roots, set posts too close, and create a problem that shows up two years later. We would rather slow down at the measure and get the layout right than rush the install and explain ourselves later."

The Glen Burnie project was completed within the company's typical residential timeline of one day to one week, depending on linear footage and site conditions. Homeowners considering a privacy fence can review the company's completed projects and customer feedback on its Google Business Profile.
