Recent updates to Georgia State Board of Workers' Compensation procedures, including revised email service requirements, modified medical release language, and clarified physician change protocols, are creating new compliance challenges for injured workers navigating the claims process.

These administrative changes affect workers across Marietta and Cobb County, from construction sites along the I-75 corridor to warehouses, healthcare facilities, manufacturing plants, and retail establishments. For employees injured on the job, understanding these procedural updates has become essential, as a single unclear form, missed email notification, incorrect doctor designation, or late report can delay wage replacement checks and medical treatment authorization. The complexity of these requirements particularly impacts workers who are already dealing with injury recovery while attempting to maintain their financial stability.

Georgia injured workers who qualify for Temporary Total Disability generally receive two-thirds of their average weekly wage, subject to the current maximum weekly cap of \$800. Workers who return to lower-paying light duty may qualify for Temporary Partial Disability up to \$533 per week for up to 350 weeks. Medical benefits are generally limited to 400 weeks, except for catastrophic injuries that may qualify for lifetime medical care. However, accessing these benefits depends on proper wage documentation, medical evidence, claim status verification, and strict adherence to reporting requirements.

"A Georgia workers' compensation claim can be damaged before the injured worker ever gets to a hearing," said a representative of Workers Compensation Lawyer Coalition. "Missed reporting deadlines, unclear medical release forms, disputed treating physicians, and incorrect wage calculations can all affect whether an injured worker receives the benefits the law allows. The recent administrative updates make professional

legal guidance even more critical for protecting an injured worker's rights."
