

Atlanta Metro Personal Injury Law Group Receives Super Lawyer Nomination Recognition

Atlanta Metro Personal Injury Law Group has received recognition through the Super Lawyers nomination process, a peer-driven evaluation system administered by Thomson Reuters that assesses attorneys across 12 indicators of professional achievement and peer recognition. The nomination comes as the firm continues to expand its car accident, motorcycle accident, rideshare, and personal injury representation throughout Metro Atlanta under Georgia's recently implemented Senate Bill 68 tort reform framework.

The Super Lawyers nomination process evaluates attorneys across more than 70 practice areas, with no more than 5 percent of attorneys in Georgia ultimately selected to the Super Lawyers list each year. The nomination represents a significant marker of professional standing within Georgia's personal injury legal community.

"This Super Lawyer Nomination reflects the quality of advocacy that Metro Atlanta accident victims deserve, particularly in the post-SB 68 environment where insurance carriers have new tools to challenge medical damages and apportion fault," said a spokesperson for Atlanta Metro Personal Injury Law Group. "Our peer recognition combined with our 25 percent flat contingency fee means injured victims receive top-tier representation while keeping significantly more of their recovery than the industry standard allows."

The firm has secured documented results including a \$15 million recovery, a \$4 million recovery, and a \$1 million recovery for Metro Atlanta car accident and personal injury clients. These outcomes demonstrate the firm's capacity to build and litigate claims at every level of the Georgia legal system.

Atlanta Metro Personal Injury Law Group charges a flat 25 percent contingency fee, compared to the industry-standard 33 percent. This structural difference amounts to tens of thousands of dollars on six-figure settlements, allowing accident victims to retain substantially more of their recoveries.

The recognition comes at a critical time for Metro Atlanta injury victims. Atlanta recorded 33,305 total car crashes in 2024, averaging 91 per day, with 13,466 injuries documented across Metro Atlanta's core counties

according to data from the Georgia Department of Transportation and Governor's Office of Highway Safety.

Georgia's modified comparative fault standard allows injured victims to recover compensation as long as they are found less than 50 percent at fault. However, insurance adjusters routinely probe early victim statements to push fault percentages upward, making the quality of legal representation the primary determinant of whether an Atlanta accident victim recovers full compensation or a fraction of it.

The ATL Metro Law Super Lawyer Nomination recognition underscores the firm's position in one of the Southeast's most active personal injury markets. Georgia Senate Bill 68, which took effect April 21, 2025, changed how medical damages are calculated, how fault is apportioned, and how non-economic damages are argued before juries. These changes have made experienced legal representation with a proven track record more important than ever for Metro Atlanta injury victims.
