North Carolina recorded 4,785 large truck crashes in 2022 according to state transportation data, resulting in 154 fatalities and numerous serious injuries. Commercial vehicle accidents often result in more severe injuries than standard passenger vehicle collisions due to size and weight disparities. Legal representation in truck accident cases involves navigating both state negligence laws and federal transportation regulations.
