

# **Universal Wellness Roscoe Village Founder Dr. John Reuter Earns Pediatric and Family Chiropractic Care Certification**

Dr. Reuter, a Chicagoland native, first encountered the benefits of chiropractic care at age 13. Following consistent chiropractic treatment, his allergies decreased substantially, his focus improved, and he discontinued the medications and shots. This personal experience directed him toward a career in chiropractic with the aim of assisting others through similar natural pathways.

He earned an undergraduate degree in kinesiology and pre-chiropractic studies from the University of Wisconsin-Eau Claire. He then received his Doctor of Chiropractic degree from Life University in Georgia. Dr. Reuter founded Universal Wellness Roscoe Village in October 2021, establishing a practice dedicated to individuals and families seeking non-invasive health support.

The clinic provides chiropractic adjustments that target spinal alignment to relieve discomfort, restore function, and facilitate the body's natural healing processes. Services address conditions including back pain, neck pain, headaches, migraines, and sciatica. Additional offerings include support for sports injury recovery,

posture correction, wellness and preventive care, and integration of modalities such as SoftWave Therapy.

As the clinic continues its established services, the recent certification enhances Dr. Reuter's ability to apply specialized techniques for pediatric and family patients. Neuro-tonal adjusting methods emphasize gentle approaches suitable for younger individuals and family members.

The practice emphasizes education, empowering patients to understand spinal health and participate actively in their wellness.

Universal Wellness Roscoe Village maintains operations centered on non-invasive techniques that prioritize root causes of discomfort.
