The firm released the information to explain common civil claim categories and the general role of legal representation following an injury.

“Clear information about the civil claims process can help individuals understand the steps involved after an injury,” said Brian Mittman, Esq., attorney at The Disability Guys. “The firm prepared this overview to describe the types of matters that may be reviewed and the records that are commonly considered during an initial case assessment.”

Personal injury law addresses civil claims involving injuries that may have resulted from another party’s conduct. These matters can arise from vehicle collisions, unsafe property conditions, workplace incidents involving third parties, construction-related events, defective products, and other circumstances governed by state civil law. Each claim depends on its facts, applicable legal deadlines, available evidence, and the relationship between the parties involved.

Motor vehicle matters may involve passenger vehicles, commercial vehicles, motorcycles, bicycles, or pedestrians. A legal review may consider police reports, photographs, medical records, insurance documents, witness statements, vehicle information, and other materials connected to the incident. The review also examines the identities of the parties and the insurance policies that may apply.

Premises-related claims concern injuries that occur on property owned, occupied, or managed by another person or organization. These matters may involve walkways, stairways, entrances, retail spaces, apartment buildings, construction areas, or other locations. Case evaluation may include an examination of maintenance records, inspection procedures, incident reports, photographs, surveillance material, and notices concerning

an alleged condition.

Construction and workplace incidents can involve several parties in addition to an injured worker's employer. Contractors, subcontractors, property owners, equipment suppliers, and other entities may have separate responsibilities under the circumstances of an incident. A civil claim involving a third party is distinct from a worker's compensation proceeding, although the two matters can involve some of the same records and events.

Product-related injury matters examine whether a product's design, manufacture, labeling, assembly, or distribution is relevant to an alleged injury. Attorneys reviewing these claims may examine the product, purchase records, instructions, warnings, photographs, maintenance information, and reports concerning the event. The legal analysis depends on the condition of the product and the evidence available for preservation and inspection.

Other personal injury matters may involve dog bites, falling objects, negligent security allegations, recreational incidents, or injuries connected to transportation and public spaces. The classification of a matter does not determine its outcome. New York law requires an examination of duty, conduct, causation, damages, filing requirements, and any defenses raised by the parties.

Medical documentation often forms part of a personal injury case review. Records may describe the initial examination, diagnostic testing, treatment, follow-up care, work restrictions, and the course of recovery. Financial and employment records may also be examined when a claim includes allegations involving lost income, treatment expenses, or other documented losses.

Legal deadlines vary according to the type of claim and the parties involved. Matters involving a private individual or business may follow different procedures from claims involving a municipality, public authority, or government entity. Certain matters require notices or filings within periods that are shorter than the general statute of limitations.
