Each program is matched to the characteristics and objectives of the individual project.

The work of Truly Investor Capital Rich Hauser reflects the company's broader mission of providing streamlined lending resources for real estate investors across multiple states. To date, the company has funded more than 116 loans, with a three-step funding process that involves structuring the deal, submitting the application, and allowing the lending team to manage the remaining steps.
