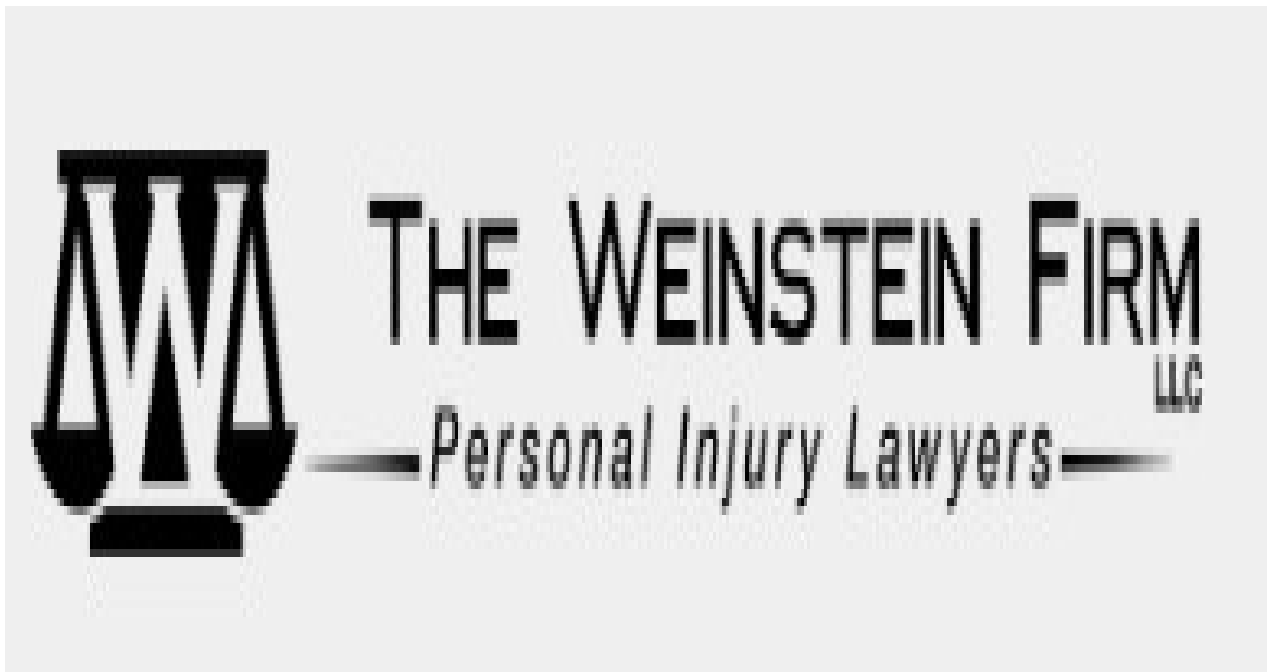




The Weinstein Firm Announces Community Backpack Giveaway Across Metro Atlanta
